### **DIRECTIONS TO WESTHAMPTON BEACH OFFICE**

*The address is: 87-131 Sunset Avenue, Westhampton Beach, NY 11978*

#### **FROM EAST VIA MONTAUK HIGHWAY:**

Head southwest on County Rd 80 W/Montauk Hwy toward Carter Lane for 4.5 miles. Turn left onto Sunset Ave. Our building's address is 87-131 Sunset Avenue in the same parking lot as CVS and across from the fire house. Enter as if you are walking into CVS but stay to the sidewalk on the left (our store front is connected to the back of CVS facing Sunset).

#### **FROM BOTH EAST OR WEST VIA SUNRISE HIGHWAY:**

Take Sunrise Highway (Rte 27) to Exit 63 South - Old Riverhead Road, towards Westhampton Beach. Travel for 2 – 2 ½ miles. You will pass Gabreski Airport on your left. Continue on Old Riverhead Road crossing over Montauk Highway and Old Riverhead Road becomes Oak Street . When you hit the traffic circle take the exit to the left which is Mill Road. Make a right at your first traffic light onto Sunset Avenue. You will see our store front on the right in the same parking lot as CVS and across from the firehouse. Enter as if you are walking into CVS but stay to the sidewalk on the left (our store front is connected to the back of CVS facing Sunset).

#### **FROM WEST VIA THE LIE:**

Long Island Expressway to Exit 70 Manorville 111. Take this road south to end and merge onto Sunrise Hwy East. Take Sunrise Highway (Rte 27) to Exit 63 South - Old Riverhead Road, towards Westhampton Beach. Travel for 2 – 2 ½ miles. You will pass the Gabreski Airport on your left. Continue on Old Riverhead Road crossing over Montauk Highway and Old Riverhead Road becomes Oak Street. When you hit the traffic circle take the exit to the left which is Mill Road.
